## 2013 Scholarship Recipients

Annually, the Guild awards two \$2,000 scholarships to two seniors residing in the service area of Thompson Health: the Phyllis Ehmann Memorial Scholarship and the Theresa Tremblay Memorial Scholarship.

Scholarship recipients must be registered in a health-related field and must successfully complete their first college semester with the intent to continue in a health-related field in their second semester.

This year all our applicants were at the very top of their class. Everyone had several Advanced Placement courses. Some had Baccalaureate courses, which are even harder. They all participated in leadership roles: sports activities, student council, class officers, team captains, first place in music awards and literary awards; they sat on school boards as a student representative or on a volunteer ambulance squad; one presented a talk to interns at the University of Rochester, several tutored their peers in chemistry, physics, mathematics, etc. The list goes on.

You name it, our 26 applicants did it. So what distinguished this year's recipients? Kathleen Duserick, Jan Bourque and Sue Winslow (the scholarship committee) picked them because, as they stated, "They were extraordinary," and they do not use "extraordinary" lightly.

Benjamin Pulver, a Naples Central School graduating senior, received the \$2,000 Phyllis Ehmann Memorial Scholarship. Ben is a gifted student who excels in math, physics and biology. He designed a robotic human arm and built an actual working arm, which he demonstrated for the audience (who were in awe). Biomedical Engineering, specifically prosthetics and reconstructive technologies, will be Ben's future endeavors in college.

Ben will be attending Worcester Polytechnic Institute in Massachusetts and plans to receive his bachelor's and master's degrees in five years. The Scholarship Committee has no doubt Ben will distinguish himself in college and achieve whatever he sets his mind to. Nobel Prize someday?

Kristy Walker, a graduating senior at Honeoye Falls-Lima, was the recipient of the

\$2,000 Theresa Tremblay Memorial Scholarship. Academically, Kristy has been a focused student who took rigorous academic programs and six Advanced Placement courses. Kathleen described her as being a very highly motivated and conscientious student and role model. Kristy received the Character Counts Athletic Award, an award not given for how smart you are or how popular or athletic you are, but how you conduct yourself at all times.

Kristy is most proud of being like a third parent to her 15-year-old autistic brother. Through him she has learned patience and compassion. Kristy participated in the TIES (Together Including Every Student) program to help students with special needs attend age-appropriate school activities. Kristy sees the possibilities in the students who

need extra help. Her personal life goal is to help others. She sees the Peace Corps as a possibility someday. Kristy will be attending Hartwick College in Oneonta, N.Y. Her chosen career path is to become a nurse practitioner, a six-year program.

## What We've Accomplished

### Past President Karen Lustick's remarks from the Annual Dinner

Over the past year, the Guild has once again been busy and productive. In 2012, we donated more than \$120,000 to Thompson Health, of which \$50,000 was for Project Excel.

Other noteworthy donations included \$10,000 towards the purchase of digital mammography equipment, and — combining profits from both this year's and last year's Springtime In Canandaigua events — \$34,000 toward the da Vinci ® Surgical System. Additionally, Thompson's leadership team recently announced its intention to open a new Women's Center for Health and Wellness. We were able to make a \$200,000 pledge towards this project, with the first \$50,000 donated at this year's Spring Dinner. In fact, with this pledge, the Guild has now surpassed \$2.5 million in pledges and donations over the past 24 years!

Of course, none of these donations would be possible without all of the fundraising events organized and carried out by Guild members. In April, we held the 2nd Annual Springtime in Canandaigua. Once again, it was at the Greater Canandaigua Civic Center, where 90 artisans displayed their wares to more than 3,000 attendees. New this year was a series of free seminars ranging from beekeeping to gardening tips. And on May 9, we held our 4th Annual Plant Sale. As they have in prior years, Miller Nurseries generously sponsored the sale by providing the plants at cost. We sold out by mid-afternoon and raised \$2,000.

In addition to summarizing our gifts and events, I'd like to welcome the Guild's new officers. Taryn Windheim is our incoming president. Taryn is a lifelong resident of Canandaigua with degrees in Communications and Political Science from SUNY Fredonia. In addition to her job as Director of the West Ontario Office of the American Red Cross, she is a member of the Canandaigua Rotary Club, Vice President of the Professional Women of the Finger Lakes and a member of the Coordinated Child Development Program Board.

Krista Jackson, who is assuming the role of Vice President, has worked in pharmaceuticals for over 15 years and lives in Canandaigua with her husband and two boys. Krista has served as the database manager for Springtime in Canandaigua and was the chair of the Tree of Lights committee last year.

Gail O'Brien has lived in Canandaigua for more than 30 years. Gail served as President of the Canandaigua Chamber of Commerce, President of the Business & Professional Women's Club and, as its first female member, President of Kiwanis. In recognition of her many contributions to the community, Gail was the recipient of the ATHENA Award in 1999. Gail is a longtime member of the Guild Board and now is a member of the executive team as Secretary.

Lou Loy, a native Canandaiguan, is stepping in as treasurer. Lou, with a degree in Engineering and experience in the business world, became Canandaigua's Director of Public Works in 1976 and served in that role for 35 years before retiring in 2011. Since retirement, he has served on the YMCA's Buildings and Grounds Committee and as a member of the selection committee for Canandaigua's next city manager. Last year, he became the first man in history to serve on the Guild Board.

I'd like to take this opportunity to offer a special thank you to the Guild officers who have stepped down along with me. To Judy Reader, our treasurer; to Marion Fladd, our corresponding secretary; and to Sue Winslow, who has served as recording secretary for the past eight years; thank you for your personal support and your many contributions to the Thompson Guild. And to everyone who contributes day-to-day in ways large and small, thanks to each and every one of you. It is your spirit of giving that defines the Guild and enriches the lives of those you touch. It's been an honor to serve as your President for the past two years.

The Greater Canandaigua Civic Center again this year proved to be a good site for this juried art and craft show.
